

## From the Grand Master

Brethren,



A new Masonic Year has begun and the holiday season is upon us. I am happy to report the continued activity among most of our Lodges with the conferral of the three degrees. I am still hearing from Worshipful Masters from all over the jurisdiction that they are very busy and aren't sure how they are going to get all of the work done. On the other hand, there are some Lodges that are languishing and wondering when they will see a new petition. It goes without saying, that I am very happy to hear from the Lodges that are active and overwhelmed with work to be done. For those Lodges that are waiting for the volcano to erupt, my message is "don't wait too long." It is up to you to look within your walls to find

the energy that exists there to make your Lodge a warm, inviting place that does interesting things and reaches out to the community in which you live so the folks who live there will know who the Masons are, and that we are just like them. Try having an open meeting or a CHIP event that will attract non-Masons to your door. Once these men understand who we are and what we do for our communities, they will want to be a part of it. If you need some help organizing an activity, the resources of the Grand Master's Office are there for your use. All you have to do is ask.

During the month of December, it is our tradition to elect the Officers who will take on the leadership role of your Lodge for the ensuing year. It is my hope that those who are elected Worshipful Master will take seriously the job they have been chosen by their peers to do. Being Worshipful Master is a job that requires management skills, leadership skills, and some financial skills in addition to the requirement to be able to confer the three degrees of Craft Masonry, a working knowledge of Article XVI of the Constitution of the Grand Lodge of Maryland and having received the Past Master's Degree. It seems that we ask much of our Worshipful Master and, we do. It is not a job to be taken lightly as you should have learned in the Leadership Seminar held last April. The Worshipful Master is the representative of every member of his Lodge when actions affecting them and their Grand Lodge are being considered. He agrees to attend on ALL committees and communications of the Grand Lodge when properly notified. This duty is just as important as is paying one's dues in a timely manner with one exception. A Worshipful Master who finds that he cannot attend the meetings of committees he is assigned to or the communications of the Grand Lodge MUST appoint a proxy to become the representative of the members. This past November, all but three Lodges had representatives in attendance which is a significant improvement from the Semi-Annual last May. I am hoping the three Lodges whose representatives were absent will see fit to attend the Semi-Annual Communication next May.

The programs that were instituted in 2009 have been very successful thus far. We will continue our efforts to resuscitate Lodges that are on the verge of going dark, the highly successful Child ID program, the Long Range Planning Committee and other projects to revitalize our Lodges and increase our membership. Updates will be reported as needed at the Semi-Annual Communication and the regional meetings.

Worshipful Masters will soon receive a letter asking for the nomination of one of the Officers of the Lodge to attend the Leadership Seminar for 2010. Information about this seminar can be found elsewhere in this issue of the Free State Freemason. In addition to the Seminar, we are also beginning to plan for the annual round of regional meetings. I urge everyone who can, to attend at least one of these meetings. The agenda is the same for all of them. They begin with coffee and buns at 8:00 AM, followed by the meeting at 9:00 AM. We strive to present interesting and timely topics for your consideration and comment. There is always time for questions and comments from you who attend so that you have the opportunity to provide needed input to your Grand Lodge Officers. The schedule for the Regional Meeting will be posted on the Grand Lodge web calendar sometime before the end of December. Please make plans to attend.

On behalf of the Grand Lodge Officers, the Office Staff and our spouses, I wish each of you a Happy Hannukah, a Merry Christmas, and a Happy New Year or whatever you personally celebrate as we approach the December holiday period and the New Year. It is truly an honor and pleasure to serve as your Grand Master and I am looking forward to a busy and productive 2010 where we will see positive growth in our numbers for the first time in many years.

To assist you with your application, please remember these few pointers:

- To allow for shipping, a \$15.00 increase has been added to the cost of the jewel.

- The Basic Jewel has 2 names: the Father and the Son. The cost for the Basic Jewel is \$80.00

- To add additional names to the jewel, include an additional \$30.00 for each bar. A jewel with 3 names would be \$110.00; 4 names would be \$140.00

- The "Lewis", traditionally, is from father to son. Uncles and nephews are not eligible to be included on the jewel.

- The fathers of your wife or mother are not eligible to be included on the jewel.



## LEADERSHIP IS BACK! We Are Looking For Many Good Officers!

Early next spring, the Grand Lodge of Maryland will again hold the Lodge Leadership Seminar. Each Lodge is encouraged to send one officer to this outstanding program. It will be similar to the one held in the Spring of 2009, but with several notable changes.



The Program was started in 2009 by MWGM Thomas M. Velvin, Jr. because he strongly believed that the Blue Lodges in our jurisdiction needed some additional help in making more knowledgeable Worshipful Masters. As is well known, our Deputy Grand Lecturers have done an excellent job in teaching ritual to our line officers. The Grand Inspectors also prepare our future Masters in the area of Constitutional Law. We did not, however, offer any training for the Leaders of our Lodges to actually become CEO's of their Lodges. As every Past Master knows, presiding over a Blue Lodge requires much more than learning the three degrees and being familiar with Article XVI of the Constitution. Proficiency in the ritual satisfies one of the two principal duties of our Masters – making Master Masons. The second of his major duties is to train his successor. To successfully accomplish that requirement entails many more responsibilities. The prescription for having an active Lodge with many programs and candidates and where the line of officers is strong is not simple or an easy task. Yet, without these traits, Lodges will find themselves in serious trouble.

In an attempt to provide valuable training for our senior officers, the Lodge Leadership Program was initiated in 2009 through a series of one day seminars in several areas of the State. Although the program was very well received, the committee took away from that first event a number of suggestions to improve it for 2010. As a result, we have a "new and improved" version for 2010.

It is going to be a one-time only event held over a weekend, instead of just a single day. The dates are March 19, 20, and 21, 2010. Rocky Gap Lodge and Golf resort will host the seminar. It is located in Flintstone, MD, just outside of Cumberland. The golfers might find the play a little challenging at that early date, however. Beginning with dinner and social time on Friday evening, through the final class and brunch on Sunday morning, the weekend promises to be challenging and fun for all.

The other major change is that we are inviting and encouraging the wives of the officers to attend. We always say how important our wives are to our success in the East. Just maybe we should help

them become a little more knowledgeable of our Masonic fraternity.

Who should attend? In Lodges where there is a full line, the ideal candidate would be either the Junior or Senior Warden. By participating in this program at least one year before his term, the Leadership Training Committee can really make a difference in his preparation as Worshipful Master. We recognize though, that not all Lodges are that fortunate. In some cases, the Worshipful Master may be the logical attendee, especially if he intends to repeat (or the Lodge needs him to repeat). It is the intent of this committee to return to each Lodge, an individual who is well versed in a number of topics which will allow him to much more effectively plan his year and to better train his successor. We will also provide him with a reference binder, or "Toolbox", which he can use throughout his term. This binder will contain a great deal more background material than we will have time to present.

Lastly, we are encouraging the wives to attend in the hope that not only will they better understand why her husband spends so much time with his Lodge, but that they can actually assist him in several social and planning functions. They may even become a fan of the Masonic family and wish to get involved with some of our collateral bodies.

As you can imagine, this is not going to be an inexpensive weekend. The Grand Master feels, however, that the investment by the Grand Lodge is well worth the expense. To help defray the total cost of the weekend, each Lodge will be asked to contribute \$200.00 for the attendee and wife (total). If any Lodge wishes to send an additional student, a cost of \$425.00 is required. That will cover the actual cost of the weekend.

How do we hope to accomplish the goals of this ambitious program? The weekend will comprise many activities – social functions, classroom instruction as well as workshops and break out sessions for the ladies as well as the officers, a keynote speaker, and, of course, more social functions...

The 6 classes and the instructors are as follows:

- The Responsibilities and Prerogatives of the Worshipful Master: MWPGM Ronald G. Bélanger and PM Harold A. Garren
- Lodge Management: RWPSGW Gerald E. Piepiora and RWPJGW Kostas Vourvoulas
- Lodge Leadership – PM Gene L. Purkey and PM Thomas A. Keller
- Membership and Mentoring – PM Frederick A. Spicer and PM Charles L. Carmichael
- Lodge Programs – PM Kenneth S. Wyvill and PM Richard P. Naegele
- Lodge Finances – RWGT William E. Gyr and PM. Ronald A. Block

There will be ample opportunity for questions and answers and most of the topics will also consist of workshops where the students will be individually challenged.

The keynote speaker for Saturday evening is Br. Christopher Hodapp, the author of *Freemasons for Dummies* as well as a number of other books and publications.

We are all busily putting the final touches on our presentations and eagerly await the 2010 Spring Class!

## Maryland Student Assistance Program (MSAP) Training

On October 20 and 21, ninety-four school-based teachers, nurses, administrators, counselors, support staff, and health professionals gathered at the Grand Lodge to be trained in the Maryland Student Assistance Program (MSAP). Since its inception in 1987, facilitated by PGM C. David Haacke, the Masonic Charities of Maryland (MCM) has sponsored this training each year and, over the past twenty-one years, training more than 5,000 people in this intervention program. MSAP seeks to identify students having problems in school that may be related to use of alcohol and other drugs or other factors and intervene with their parents to raise their awareness of the problem and offer assistance for their child. All costs of the training are borne by MCM and a strong partnership has been forged between MSAP and MCM, who are jointly committed to helping our at-risk students. Through fund-raising enterprises, such as the MCM Golf Tournament, described herein, and other events, including individual contributions, MCM is able to carry on the work to help these at-risk students as well as provide scholarships for graduating seniors each year in June.

His military awards include: two Purple hearts, Navy-Marine Corps Commendation Medal, two Combat Action Ribbons, Navy Presidential Unit Citation, Navy Unit Commendation, two Marine Corps Good Conduct Medals, National Defense Service Medal, Afghanistan Campaign Medal, two Iraqi Campaign Medals, Global War on Terrorism Expeditionary Medal, Global War on Terrorism Service Medal, four Sea Service Deployment Ribbons, NATO Medal and two Certificates of Commendation." Charlie was awarded his third Purple Heart and rank of Staff Sergeant posthumously at his funeral in Union Bridge, Maryland. Charlie leaves behind many family and friends including his mom, dad and wife of 11 months. Charlie was an outstanding DeMolay and a true Patriot.

## 100th Anniversary Celebration of the George Washington Masonic National Memorial Association

On February 22, 1910, George Washington's 178th birthday, Masonic leaders from across the nation met in Alexandria, Virginia and formed an association for the purpose of building a great memorial to honor America's foremost Freemason. February 22, 2010, the 100th Anniversary of the founding of the George Washington Masonic National Memorial Association, will be a day of great festivities.

In honor of the occasion, the Conference of Grand Masters of North America, hosted by the Grand Lodge of Virginia, will be held in nearby Arlington. Delegates will attend the Association's Annual Meeting and celebrate the 100th Anniversary and Washington's 278th birthday at the Memorial. At the Annual Meeting, a new portrait of George Washington as a Freemason will be unveiled. Painted by local artist, Christopher Erney, the portrait will be a new interpretation of Washington.

Prints of the portrait will be available at the meeting. Complementing the portrait is a new video. It presents George Washington as the inspiration for the founding of America and explores the founding of the George Washington Masonic National Memorial Association. Underwritten by the Masonic Charity Foundation of Oklahoma, it will be available on DVD and as a download from the Memorial's website for Masonic education. The Memorial's new logo to commemorate the occasion was also designed by local artist Christopher Erney. The logo combines the Washington Family Crest with numerous Masonic symbols. Its Square and Compasses is taken from the Memorial's 1923 cornerstone affirms the Association's motto "In Memoriam Perpetuum" as it supports Freemasonry in a new century of service.

Following the Annual Meeting, the International Order of DeMolay will rededicate the colossal bronze statue of George Washington in Memorial Hall and reaffirm the role of DeMolay young men in Freemasonry. The statue was a gift to the Memorial from the DeMolay and 2010 marks the 60th Anniversary of its unveiling by President and Past Grand Master Harry S. Truman. On display during the celebration will be the Trowel and Gavel used at the 1793 Cornerstone Laying of the United States Capitol by George Washington and the 1752 Fredericksburg Lodge No. 4 Bible upon which a young Washington took upon himself his Masonic obligations. The new White House Stones Exhibit will be inaugurated at the celebration. Each stone in the exhibit is marked by one of the Scots Masons who helped build the White House in the 1790s.

The stones were discovered during the restoration of the White House by President Harry S. Truman in 1948. President Truman had the stones labeled and one was sent to each U.S. Grand Lodge and other Masonic organizations.

The Exhibit reassembles nearly 50 stones. The Exhibit also includes minute books from Lodge No. 8 of Edinburgh recording the stonemasons' marks and noting those who have "gone to America." A matching Minute Book of Federal Lodge No. 1 will show those Scots masons forming the first lodge in 1793 on White House grounds. The exhibit is

supported by the Ancient and Accepted Scottish Rite of Freemasonry, Southern Jurisdiction, Valley of Washington, Orient of the District of Columbia, and by the Grand Lodge, F.A.A.M., of the District of Columbia.

A gala reception will be held in Grand Masonic Hall and while the Annual Meeting is being held the ladies will enjoy an entertaining program in the North Lodge Room. A Centennial Celebration souvenir booklet containing a brief history of the Association including historic and current photographs will be distributed and several commemorative gift items will also be available and on display.

2010 is a unique celebration year for the Memorial Association. Together we are celebrating 100 years of dedication to Freemasonry's greatest brother and honoring the countless brothers who built and sustain the Memorial. Equally important, 2010 marks a pledge of rededicated service, trusting in God that the century ahead will be filled with success and achievement.

## Rushmore Presidents

On Wednesday, October 21st, the Grand Lodge of Maryland hosted four of the most prominent figures in American History in the Corinthian Room of the Grand Lodge.

Local area Middle and High schools were invited to meet with George Washington, Thomas Jefferson, Abraham Lincoln and Theodore Roosevelt. Each former President spoke about the condition of the United States at the time of his office and welcomed questions from the students and teachers.



An encore presentation in the evening was open to Masons, families, friends and the general public.

The four historic re-enactors performed for an almost full-house. There was captivating dialogue between the presidents and the guests. The question and answer portion of the event was the most enjoyable, as guests were able to interact with each of the presidents.



The evening ended with the actors finally breaking character (after 10 hours in character) and answering questions about portraying these notable figures.

### Infection Control Practices At Maryland Masonic Homes



My name is Elé Lundgren and I am the Infection Control Nurse for the Masonic Homes. It is my responsibility along with all staff to ensure that we provide a safe and healthy environment for our residents. Earlier this fall we began the process of looking at the safety of our community related to the Influenza Season and the H1N1 Flu Virus. I thought it would be interesting to outline the practices in which we ensure infection control measures.

We spoke with the Department of Mental Health and Hygiene and followed their recommendation of screening all family, visitors, vendors, and contractors entering the community. We have posted in our lobby information pertaining to symptoms of the flu and have developed a simple Screening Tool that we ask each individual to complete prior to visiting with residents.


We have engaged Environmental Services to heighten cleaning procedures of handrails; elevator buttons, door knobs, and any surface areas that are frequently touched. Bottles of hand disinfectant gel are placed at all entrances to the community and individual smaller bottles are available to all staff. We have also posted signage throughout the community promoting proper hand washing and cough etiquette.

We believe our Flu Free environment has been a direct reflection of our infection control practices! From all the staff and residents of Maryland Masonic Homes we wish you a safe and healthy new year!

In the last issue of the Free State Freemason, I wrote about the “Bonnie Blink Resident Council,” when it was formed, the officers, our meetings and our money-making projects. The money we make goes to donations for worthy causes. There is one donation we made to the Armed Forces Foundation that I would like to give you more details about.

My son, John Frech, is Vice President of Maryland Chapter IX of the Blue Knights. In his own words, he told us about our donations:

“The Blue Knights, Maryland Chapter IX is part of an international organization in which members of law enforcement can experience the enjoyment of riding motorcycles. There are two basic qualifications to become a Blue Knight: you must own a motorcycle and you must be an active officer in law enforcement or a retiree in good standing.

Maryland Chapter IX has been in existence for only five years. When initially started, we dedicated the chapter to honoring our wounded military soldiers. Since our inception, we have held an annual Purple Heart Ride in efforts to raise money. Each year the ride has been from Freedom Park in Sykesville to either Bethesda Naval Hospital or Walter Reed Hospital, where we make the presentation. Prior to the ride we try to get as many sponsors as possible. We are very fortunate that the Resident Council at the Maryland Masonic Homes has been one of our

sponsors for the past two years. One hundred percent of the monies collected have gone directly to the Armed Forces Foundation. This foundation assists the wounded soldiers and their families in their time of need, and just this past year our Chapter was able to donate over \$11,000 to the foundation.

Our chapter feels very appreciative to the groups that have sponsored our ride, as we as the individuals that show up in June for our PHR ride. This year we were able to show our appreciation in a small way. One of our members has a son who is currently serving his third tour in Afghanistan. We thought it would be nice if we delivered a few American Flags to him to fly during his mission. James Weiglen, Jr. was more than happy to do this. After they were flown during a mission, he sent them back home, and we were able to present them to a few of our contributors that have donated for at least two years running.

We realize that during these tough economic times, it is difficult getting people to contribute. The resident council at the Maryland Masonic Homes has been very gracious in donating \$500 each of the past two years. The Blue Knights, Chapter IX felt that it was an honor for us to bestow a flag and certificate as a small way for us to show them our appreciation.”



When John made the presentation of the flag and certificate to the Council, I was honored and proud because I wanted the Council to be recognized beyond our four walls and now we have reached half way around the world.
