## A Formula For Success Can "Make A Difference"

From the Grand Master:

My Brethren:

For the past 12 months I have tried to impress upon the Craft the importance of sharing what and who we are as an organization with our friends and relatives. Many of you have heard me speak to the concept of not having a "Membership Problem" but rather an "Identity Problem." I have tried to encourage the membership to become more vocal about who and what we are. I have even offered primers that I and the Chairman of our Education

Committee feel are "must reads" for any Master Mason. I feel we must all be ready to speak on the subject of Masonry intelligently and being well read and prepared is a part of that exercise.

Do you know what you are a part of? Are you willing to allow non-masons to define who you are? Are you proud to be a Mason? Are you prepared to speak about the philanthropic endeavors of our various collateral bodies? Almost all of which, by the way, involve the care of youth. There are more questions to ask of course but I trust you are starting to get the picture. My formula for success is really quite simple:

Identity plus Image will equal membership.

Identity is simply a way of defining to our acquaintances who we are and especially who and what we are not. We've all heard the "cult" concept thrown around yet we who are members know there is nothing cult-like in any of our ritual or teachings. If we choose not to respond to these baseless charges then we are allowing others to define us. We must be careful not to enter into shouting matches with religious or political fanatics as there will never be meaningful or thoughtful discussion with those of that ilk. If however, you find yourself in a meaningful discussion with individuals of some intelligence, being prepared to speak with those who show an ability to listen, you will find that sharing the truths of Masonry can be an exhilarating experience. # Silver Spring Lodge in Action

Each "Good Samaritan" donated \$100.00 a year to the lodge to support this humanitarian effort. It has been reported that nearly 1,600 persons seek shelter each night in Montgomery County alone.

To date, we have raised neary \$6,000 to help bring unfortunate persons, many of them children, from drafty shelters into temporary warm homes where they can have a place to study.





# GRAND COMMANDER'S MESSAGE

Sir Knights- We are now squarely implanted in the autumn of the year. Children are back in school, and we are in the season of Halloween (from the Celtic "Samhain," pronounced Sahween, which means "end of summer"). These are the early-darkening days that inspired the wellknown Cornish prayer, "From ghoulies and ghosties and long leggety beasties and things that go bump in the night, Good Lord deliver us!"

Celtic stories that grew up around Samhain were ultimately set down by Christian scribes. In stories populated with supernatural

creatures, the human and spirit worlds were said to merge on Samhain. People disguised themselves as ghosts and goblins as protection against evil. Food was an offering of respect for the dead who were believed to return home. All Saints' Day, also known as All Hallows Day, and All Souls Day -November 1 and 2, respectively -were Christian holidays established to replace Samhain. The celebration begins on the evening of October 31, All Hallows Eve or Halloween. Obviously, these traditions continue today in the more benign manifestation of Trick or Treaters besieging neighbors for candy every October 31. Besides, we probably all enjoy a little scare once in awhile.

Beyond the juvenile heebie-jeebies and mischief making of its youngest members at Halloween, Western Christian society more soberly acknowledges and celebrates All Saints' Day, November 1st. Historically, it was Pope Gregory who in 835 A.D. ordered that the Feast of All Saints be universally observed on November 1st. Different denominations and sects have attached differing traditions of belief to the day. Roman Catholics, the Orthodox, and Anglicans it is the occasion for remembering, honoring and praying to all the saints in heaven. After the Reformation (and consequentmost present-day ly, for Protestants), it is a date to remember and honor all those who have gone before us. Most important for all Christians, it is a time to glorify Jesus Christ who, by His holy life, death and resurrection, has made us all holy through Baptism and faith.

So first we watch amused as our children and grandchildren dress in outlandish and spooky garb to clear their neighbors' shelves of all candy and goodies. Then we turn our hearts and minds more seriously to remembering and honoring our predecessors, our departed fraters and loved ones, exemplars who have provided the "warp and woof" of our lives, beliefs and standards.

I urge you to search your heart and memory for those most deserving of recollection and honor in your life. Give thanks for them; they helped make you what you are today.

We have much to give thanks for. Those present at the "Friend to Friend" Observance in Gettysburg in late September know that we have, among other things, reason to give thanks for our Pennsylvania brethren for their kind invitation to us to once again be part of this singular service, honoring those who fought so bravely on opposite sides of the great battle set in a tiny farming town. And clearly, though on opposing sides, at least some of these soldiers of North and South saw their attachment to Freemasonry as encouragement (indeed mandate) to view their adversaries first as brothers and treat them as such.
