My Brethren,

The statewide Regional Meetings are finally history. This concept has proven to be a very successful and informative tool for the Grand Master and Brethren to jointly share information. We, your Grand Lodge officers, set the agenda, then the remainder of the meeting is basically an informational conversation between Grand

Master, Deputy Grand Master and those in attendance. No subject is untouchable. Strange as it might seem I like the concept. We, the Grand Lodge, have nothing to hide and you have a right to know in which direction your Grand Master is taking this Grand Lodge. The question and answer part of the program often reveals important concerns of interest to you, and can serve as a wake-up call to us. We need and want to hear those rumors, always there, and which take a life of their own. I welcome the opportunity to address the rumors, give them recognition when they are correct and stop them when they are "off base." We need to be, up-front with you. The only subject we will not discuss is an item of a personal nature. If any brother wants to learn specific information about another brother, he will have to go to the source.

While at Hagerstown Lodge No. 217 for one of the Regional Meetings, a very legitimate question was presented. It was a perfect example of how a longstanding policy/rule has outlived its purpose. The question was asked of the Grand Master: why does the Lodge need Grand Master's approval for a variety of the small changes required to "get the job done?" The questioner presented several examples, such as; to open a Lodge ahead of its normal time for Degree work; for an Open Installation of Officers; to have a Ladies Night; to make an early pin presentation because of health reasons, etc. It was a very (continued on page 3)

(continued from page 1) good question which I believe deserves an answer. After that meeting I reviewed past dispensations issued and then issued a letter removing the requirement for some of those dispensations, while maintaining all the necessary controls required for future Grand Masters. That question was a very good example why our Grand Lodge Constitution needs to be constantly reviewed and amended where necessary. We must continue to make progress or we shall decline. Nothing stands still, especially in American society. Our younger Brethren honor our history, but they also wonder why we are so unwilling to change. Don't be afraid of change. It's a necessary part of life. Embrace it and use it for the betterment of the fraternity. A copy of my letter is part of this edition.

This years' Grand Master's/ Grand Secretary's Conference, in Washington DC, introduced some very interesting subjects to be discussed. One major change that is taking place throughout many Grand Lodges regards the "One Black Ball" vote. The general feeling among many of the Grand Masters was the change is warranted. Some Grand Lodges have already changed their Constitution and voted to accept a three (3) negative vote ballot. Almost everyone present had his own examples where petitioners were rejected by the one, possibly personal, negative vote. The general conclusion was now is the time, with falling membership, to take a fresh look at this problem. I am not sure how I would vote, but I will say we need to at least address the problem. It is not going away anytime soon. At the Regional Meeting in Salisbury, it was suggested perhaps another approach might be to remove the Lodge Personal Jurisdiction after a negative vote. The petitioner would then be free to petition another Lodge should he so desire. The Worshipful Master who suggested this change said he had been rejected 13 times before he was finally accepted. I do not believe I would have persevered had I been rejected 12 times. To me it would have been a clear signal I was not wanted in this fraternity long before I reached the number 12. As you can see, my Brothers, there are many ways to approach a problem. It is imperative we choose the correct answer that solves the problem and does not create another one.

Speaking of Amendments to the Constitution, there will be three new ones presented in May, at the Semi-Annual Communication. For those Brethren who cannot attend their Lodge because of health, age, or distance from the Lodge the following amendments will to be voted upon:

Amend Article X, Section 1. D.1. of the Constitution to increase the Grand Lodge assessment from the present \$ 6.25 semi-annually to \$ 9.25 semi-annually. My Brethren, Grand

Lodge needs your support on this amendment. There has not been an increase in the assessment since November 1987. I understand the feeling prevalent among the Brethren but the time for healing is now. We, the present Grand Master and Deputy Grand Master did not build the Grand Lodge building, but it's here. We have to move on, keep this Grand Lodge strong and work on solving today's problems.

Amend Article X, Section 1.D.3. of the Constitution to basically double from \$100.00 to \$200.00 the fee presently charged for a Petition for Initiation and \$50.00 to \$100.00 fee for a Petition for Affiliation from another Grand Jurisdiction. The first \$100.00 of the new Petition for Initiation fee would go to Grand Lodge and the entire fee for affiliafrom another Grand Jurisdiction would go to Grand Lodge. The Brother submitting this amendment believes we have set our standard fees too low.

Amend Article VII, Section 3 of the Constitution to allow the Grand Lodge to cast their vote for all candidates who meet the qualifications and wish to serve as a member on the Board of Managers, Board of Trustees or Masonic Charities of Maryland. Presently those candidates who meet the qualifications to serve, submit their resumes to the respective nominating committee who then nominate the most qualified to serve. (continued on page 4)



(continued from page 3) Grand Lodge will then elect a Master Mason, from that list for all vacancies on each Board. Passage of this amendment would require the nomination committee to present all qualified Master Masons, to the Grand Lodge for an open election to determine membership on each particular Board. Should this amendment pass it would mean there could be no nominations from the floor because the Nominating Committees would be unable to determine the qualification of that nominee prior to election.

There are several additional amendments to be submitted and then voted on in November at the Annual Communication of Grand Lodge. My Brethren, I am pleased this Grand Lodge has finally begun taking those positive steps towards the modernization of our rule of law, the Constitution.

I, myself have offered an Amendment to be read in May and voted on in November, permitting nomination of Blue Lodge Officers. It has always remained a mystery to me why the Grand Lodge can nominate, from the floor, while the Blue Lodge is not permitted the same courtesy. My amendment to Article XVI, Section 3. Subsection A. states: Nominations for the Worshipful Master, Senior Warden, Junior Warden, Secretary and Treasurer may be made and seconded from the floor (in the same manner as done in Grand Lodge). Nomination declarations shall consist only of the name of the brother, who must be a Lodge member, making the nomination, the name of the nominee and the elected office. A second from the floor is required. That Brother will give his name and declare he seconds the nomination. There shall be no nominating speeches. The nominee may stand in place to be recognized. He must either accept or reject the nomination.

I have also submitted to the Committee on Masonic Jurisprudence four (4) other small amendments to the Constitution which will be read in May and voted on in November. This is just my intent to change those housecleaning items that had been outlived their useful purpose. One amendment reflects the size of the Lodge communication. Today almost every Lodge uses a computer and their communication is letter-size.

My Brethren, as Grand Master I am not always in touch with the world as you know it to be, so please feel free to enlighten me. This Grand Lodge can work as well as your individual information permits it. We need and must work together for the good of every member of this Grand Lodge.

Philanthropic No. 168

"A Fraternity within a Fraternity" Philanthropic Lodge No. 168 in New Market, Maryland is growing. While we may not be the largest, newest or fastest growing Lodge in the State, we have been growing at an impressive rate.

This is, in no small way, thanks

to the Free State Shield and Square Club Degree team. They have raised nine of our current members and while there, they strongly encourage the newly raised Brothers to become active in their Lodge. This has provided our new members both interest and motivation, and they in turn, have brought other petitioners to us.

There are plans to have the Team raise at least four more Brothers over the next year. In addition to these, there are also four more that have petitioned the Lodge for admission.



My Brethren, I had originally written a message encouraging your participation in Grand Lodge. You know me; "get out and vote, participate, get involved, be



I trust you will take what I have to say next to heart as well. I'm sure by now you have all been made aware of the terrible accident that has taken place in the state of New York. There can be no excuse for this senseless loss of life. and our hearts, thoughts and prayers go out to the family members who will be forever affected by the loss of our Brother. We all know the accidental shooting of this "initiate" into some "Fellow Craft Club" or auxiliary unit of that Lodge had nothing to do with the esoteric work of Blue Lodge Masonry or any other form of Masonry for that matter. This unsanctioned and unauthorized "ritual" can only be viewed as illegal. There are no provisions in Masonic Ritual for a weapon of any kind. In fact we are taught that we are to bring nothing "offensive or defensive" into a lodge room, period.

How do we defuse what has happened in New York here in Maryland? We don't or maybe it is better stated: "We can't." If you are approached and asked about this horrific accident I trust you will remain dispassionate and calm. Let your family, friends and acquaintances know that weapons of any kindare not a part of Masonry. We as a Fraternity are guided by a code of morality which should govern all of our actions. What has occurred in New York is much more than highly irregular; it falls well beyond the bounds of acceptable behavior. It certainly violates that (continued on page 6) code of



(continued from page 5) morality we have all submitted ourselves to upholding and promoting. College fraternity high jinks are not a part of Masonic ritual, nor have they ever been endorsed or tolerated by any Grand Lodge jurisdiction when brought to the attention of our Masonic leadership.

The message Masonry offers does not need to be reenforced by childish pranks or over exuberance. The belief in the Fatherhood of God and Brotherhood of man is in and of itself a powerful enough message, and we should concentrate on letting the public know we are against such illegal and unofficial practices without becoming argumentative. Finally my Brethren, poor judgment and downright stupidity has caused the loss of an innocent life; there is no denying that fact. To a brother, each and every one I've spoken to immediately express deep concern for the family members of our departed Brother, showing little concern for themselves or the Fraternity. Let there be no mistake: because of the senseless and irresponsible actions of a few, millions of good upstanding individuals. Masons worldwide have had their names besmirched, and the greatest fraternity in the world has been tarnished. Now more than ever we must show the world what real Masons and real Masonry is about. We are taught that all men are entitled to our regard. I trust you will keep all involved in this totally unacceptable behavior in your thoughts and prayers.

Office of R. W. Grand Secretary Vacant

It has been brought to the attention of the Grand Lodge of Maryland A.F.&A.M. that R.W. Brother Jack R. Frazier will not stand for re-election as our R.W. Grand Secretary in November of 2004 leaving the office of Grand Secretary vacant. Any permanent member of Grand Lodge, as defined by the Grand Lodge Constitution, may be eligible for election to this position. It is requested however that a resume be submitted to Grand Lodge that it may be included in the next issue of the Free State Freemason. The deadline for this submission is June 1, 2004.

Your Board of Managers has also determined that your Grand Lodge would be better served if the day-to-day operations of the office were turned over to an office manager, leaving the Grand Secretary to deal with communications between the Blue Lodges Lodge and Sister Grand Jurisdictions. To this end the annual compensation for the office of Grand Secretary has been restructured to reflect this change. A stipend of \$10,000 per year along with a standard rate of travel pay, as determined by the Board of Managers, will be awarded to the position of Grand Secretary.

This action by the Board of Managers also necessitates the search to fill the new position of Office Manager. While this search will not be limited to only members of the Craft, it is felt that the first option to fill this position should be made available to the membership. Therefore: anyone interested in the position of Office Manager should submit a resume no later than June 1, 2004 to the personnel committee of the Board of Managers in care of the Deputy Grand Master. All duties and compensation will be discussed and explained at the interview with the personnel committee.

Dispensations

Regional meetings throughout this jurisdiction serve an important function.

We, the Grand Lodge Officers, are able to communicate our programs, Grand Lodge financial status and other general information critically important to you.

I am always pleased to present our Grand Lodge information, open a two-way dialogue with those present, and attempt to reach a reasonable conclusion.

We need each other's support, and that can be gained only by a an open discussion of our operation. Is there a better time or place to discuss subjects of mutual importance? My quick answer is no. We need to bring forth those seemingly unsolvable problems and solve them!

At the February 28, 2004 held Regional Meeting Hagerstown Lodge No. 217, a Brother posed a question for the Grand Master. The crux of his question exposed a system overburdened with paperwork. He wondered why the Grand Lodge requires a Special Dispensation before a Lodge can make a change from its normal procedure. My short response was, "If the request does not violate the Constitution of the Grand Lodge this should not be a problem." After that meeting, we reviewed at Grand



Lodge, the requests and our overwhelming number of favorable responses. Grand Lodge history indicates Dispensations were requested and granted almost automatically.

Many labor hours, yours and Grand Lodge's, were wasted sending or responding to these requests; this did not even include the postage paid, yours and ours.

Therefore, with prior notification to your membership via the Trestle Board and your Grand Inspector, it will no longer be necessary to request a dispensation from the Grand Master for the following actions:

Open your Lodge at a time other then the regularly stated By-Law time.

Change a scheduled communication for the purpose of honoring a member, or his Masonic birthday, or celebrate Masonic Widows Night, or Ladies Night, or have a Table Lodge, or to confer Degrees such as Rusty Nail, Empty Chair, etc.

Schedule a Special Communication, on other then a meeting date, for Masonic Degree work.

Divide the Master Mason lecture, on Past Master's Night, among qualified Past Masters.

Hold a public Open Installation of Lodge Officers. The Masonic ritual and rules for an Open Installation are clearly spelled out in a previous Edict and shall be adhered to in all Lodges. No deviation shall be permitted.

Request a waiver concerning a candidates' physical handicap

and/or his inability to perform certain actions during the conferral of Degrees. His condition should have been addressed when the petition was submitted to Grand Lodge.

Take part in a public parade, or be a "bell ringer" for charity, or assist in community events, etc.

Present a 50, 60 or 70 year Masonic Emblem prior to the scheduled date for health reasons, or as a convenience for an out-of-state member, or for planning of future Trestle Board items. Prior notice of this change must be made to the Grand Lodge office to assure presentation materials will be available. This is a "notice" not a dispensation request.

Written requests for Dispensation from Grand Master are still required for;

Permission to hold an election of Officers other then the regularly scheduled meeting in December.

Initiate more the five (5) candidates at one meeting, or confer more then one (1) degree on a Brother at the same meeting.

Permission to initiate a candidate on the night of his election.

Confer or perform proficiency of Maryland ritual in another jurisdiction.

All other Lodge activities not specifically identified above.

My Brethren, we need to address our problems openly and make those necessary changes to keep our Fraternity fresh and inviting to prospective candidates. Thank you for your thoughts and input. Working together we can make the difference.


