



MESSAGE FROM THE RW DEPUTY GRAND MASTER


Have You Noticed?

Here at the Grand Lodge we monitor membership because it is the lifeblood of our fraternity. I have noticed that we are experiencing a steady and increased flow of


certain the light is shining so that we can all find our way.

Francis Edward Larrimore, Most Worshipful Past Grand Master

ost Worshipful Past Grand Master Francis "Fran" Larrimore will be long remembered by all whose life he touched. His warm greeting and firm handshake were a constant. His love of his family, his country, the United States Marine Corps and Freemasonry never wavered.

Born on April 25, 1921, Bro. Larrimore was raised in Linthicum, Maryland. In 1942, in the midst of World War II, he enlisted in the Unites States Marine Corps at the age of 21. His military career was distinguished by his participation as a member of the 5th Marine Division during the heroic landing and action against the Japanese on Iwo Jima as well as the occupation of Japan. He was honorably discharged in 1949 with the rank of sergeant. Sergeant Larrimore joined the United States Marine Corps Reserves in 1950, and served throughout the Korean Crisis before being honorably discharged once more in 1961. Throughout his post-military life, he remained an active member of the 5th Division Association, the Marine Corps League Baltimore Detachment and the Marine Corps Association.

After leaving the military, Bro. Larrimore went on to a successful business career as an executive with Carpet All, Inc., Larrimore Associates, Inc. and Lancer Enterprises, Inc.

His Masonic life began in 1985 when he petitioned Sincerity Lodge No. 181. He received his Entered Apprentice Degree on November 7, 1985; his Fellowcraft Degree on April 17, 1986; and was raised to the Sublime Degree of Master Mason on October 2, 1986. In short order, he became a lodge officer and was first elected as Worshipful Master of Sincerity Lodge No. 181 in 1990. He again served in that position in 1994 and again in 2009.

The culmination of Bro. Larrimore's Masonic career came with his election as Most Worshipful Grand Master of Masons in Maryland in 1999 and 2000. His term in office was highlighted by his determined effort to ensure the growth and financial stability of the Grand Lodge of Maryland. He instituted Maryland's very first one-day class in which 328 men were initiated, passed and raised as Master Masons on one day. His leadership led to the implementation of the Portals Program for the Masonic education of new members, a program still in use today. He also led the effort for the creation of St. Alban Universal Lodge No. 231 and granted their charter.

Bro. Larrimore was deeply involved in Masonic activity within the concordant bodies both before and after his years as Grand Master. Within the Scottish Rite he received the

KCCH in 1999 and was awarded the 33° in 2009. In the York Rite, he was a member of Concordia Chapter and Council No. 1, York Council No. 23 and Maryland Commandery No. 1. He belonged to the Tall Cedars of Lebanon Baltimore Forest and served as Past Preceptor of the Royal Court. As a member of Boumi Shrine he was active in A.A.O.N.M.S., the Ceremonial Team, the International Shrine Yacht Club and the Knights of Mecca. He was also a member of Yedz Grotto, the Past Masters Association of Baltimore, the Masonic Veterans Association, Bonnie Blink Daylight Lodge No. 1 and the National Sojourners – Fort George G. Meade Chapter No. 4. He was Past Sovereign of St. Cyrian Conclave, Red Cross of Constantine.

In addition to his years as Most Worshipful Grand Master, Bro. Larrimore served the Grand Lodge of Maryland as Worshipful Junior Grand Steward in 1992 and as Right Worshipful Deputy Grand Master in 1997-98. He was a Grand Inspector from 1993 until 1999. He was also elected to the Grand Lodge Board of Trustees in 1993 and served until 2002, including being named Chairman of the Executive Committee. In honor of his many years of dedicated service to Maryland Freemasonry, he was awarded the Thomas J. Shryock Medal for Distinguished Service.

Bro. Larrimore is survived by his loving wife Camelia, his son Larry Larrimore and his daughters Debra Malinowski and Joyce Hawes. He was also a devoted grandfather of five grandchildren; Christy, Bree, Erin, Jessica and Eli as well as five greatgrandchildren. As a patriotic American, a war hero, a Freemason, a husband, a father and a friend; Bro. Francis Larrimore will be sorely missed and fondly remembered for eternity.



ne of the pioneer collectors of American Art and Ameri-Cana was Baltimore physician and Master Mason William H. Crim (1845-1902). Born near Lovettsville in Loudon County, Virginia on January 8, 1845 his talents and tastes would bring him to the forefront of Baltimore society. After completing a collegiate course at Gettysburg College, Pennsylvania, William Crim began the study of medicine in a private office in Lovettsville, Virginia. Latter he matriculated at the University of Maryland, completing his training in 1870 with a year's residency at University Hospital. In March of 1873 after moving to Maryland he petitioned and was raised in Oriental Lodge, No. 158 shortly after they were founded (Oriental Lodge, No. 158 Chartered June 27, 1871).

From all accounts, it may be inferred that, Dr. Crim was a remarkably energetic individual. In addition to practicing medicine in Baltimore as a surgeon and physician, he conducted private classes in medical instruction. He was also active in the Fifth Regiment Infantry of the Maryland National Guard, serving as Captain and Assistant Surgeon from 1872 to 1880, and subsequently as Major and Surgeon in 1881. Dr. Crim participated in all the regiment's campaigns until age disqualified him from service just prior to the Spanish-American War.

As a collector his tastes were eclectic and objects, particularly furniture, were often embellished. Historical associations and patriotic sentiment appear to have determined the course of his collecting with the majority of his collection having historical ties. Among the items crammed into his Baltimore residence at No. 413 West Fayette Street were furnishings that had belonged to Robert Gilmor (1774-1848) and the Princess Mathilde (1820-1904), Daughter of the King of Westphalia, Jérôme Bonaparte (1784-1860), the husband of Baltimore native Elizabeth Patterson Bonaparte (1785-1879). One of the more imposing items

was a life-size marble group depicting the 'Three Graces' by the Italian sculptor Antonio Canova (1757-1822) previously owned by General George Washington Whistler (1800-1849), father of the artist James Abbott McNeill Whistler (1834-1903). His obituary published on November 16, 1902 in the New York Times noted that "Dr. Crim's home is a museum of rare antiques. The spacious old-fashioned house in West Fayette Street is filled with paintings and curios. An extension table in the quaint dining room was used by President Lincoln during his first term in the White House. Two spoon urns belonged to Charles Carroll of Carrollton. A double sofa, a card table, and hall chairs by Chippendale, that once graced the library of Chief Justice Taney, ... a secretary presented by the French Minister to President Buchanan, and a book

case with diamond cut glass doors, an heirloom in the family of Commodore Buchanan of the Confederate Navy, are part of the collection. In one of the bedchambers is the famous Lafayette bed, a massive four-poster, which stood in the room occupied by Lafayette at the old Fountain Inn during his visit to Baltimore [in 1825]. Another four-poster is of the famous Jefferson design. The walls of one curio room are lined with weapons of the last 200 years. A pistol, two pikes, and a rifle that were used by John Brown and his party at Harper's Ferry occupy a prominent place."

His southern sympathies in the then 'Late War' are evident in his participation in the dedication of a statue of General Robert E. Lee (1807-1870) by French sculptor Antonin Mercié (1845-1916) in Richmond in May 1890, for which he personally designed the fasces-shaped floral arrangement. He also obtained for his collection a number of notable Confederate relics, including the percussion cap revolver manufactured by Leech and Rigdon carried through the War by Confederate Col. Harry Gilmor (1838-1883) of Maryland.

After his sudden death on November 15, 1902 from heart disease at the age of 58 his widow, Mrs. Ella G. Crim (?-1903) formerly Mrs. Hazleton of Philadelphia, placed his collection on the auction block. In Baltimore for ten days, April 22 to May 4 the public flocked to the Fourth Regiment Armory to bid or merely gape at the liquidation sale of Dr. Crim's collection. Consisting of a total of 2,941 lots and realizing the sizable sum of \$70,000, the auction was immediately followed by a second sale of miscellaneous items sold in his residence consisting of architectural salvage and his rare book collection which included a set of Audubon's Birds of America. The press reported the proceedings daily, noting how "local society folk collectors and dealers" contended "good naturedly against out-of-town curio



hunters." The highest price at the auction, however, was \$8,000 paid by a New York dealer, acting on behalf of the Gould family, for eight armchairs optimistically attributed Thomas Chippendale (1718-1779), which had formerly been in the possession of Francis Scott Key (1779-1843).

Among the many objects in his collection were a number of items decorated with Masonic symbols. While many of these items were sold in the 1903 sale, including lot 1615 "Rare Old Liverpool 'Masonic' Pitcher, an Exceptionally Fine Piece," Dr. Crim also bestowed some items to friends while others were privately sold after his passing by his widow to members of the fraternity. Grand Master John M. Carter (1843-1915) once owned a piece of antique 'Cut Work' lace depicting a quantity of Masonic Symbols from Dr. Crim's collection while Alfred E. Mealy appears to have obtained an early Chinese export punch bowl decorated with Masonic symbols. This bowl was subsequently presented to the museum in 1910 and is currently on display in the museum gallery.

Though Dr. Crim's collection represents the result of a patriotic zeal that coveted historical associations, his collection represents one of the earliest of it kind to be formed in the United States. While his collection was largely dispersed after his death it has left a lasting impact on the scholarship in the field of the American arts with items from his collection now residing in other institutions including the Baltimore Museum of Art and the Maryland Historical Society.

Student Assistance Program Training

n February 25 & 26, forty-seven educators, health care professionals, and other community resource personnel from Prince George's County participated in a Masonic Model Student Assistance Program (MMSAP) training at the Prince George's County Staff Development Training Center in Oxon Hill, MD. Led by trainers Larry Newman (a California Mason) and John Bearoff, the trainees learned the enhanced intervention program and prepared to return to their schools to provide

assistance to students whose success in school is jeopardized by falling grades, poor attendance, or bad behavior. Funding for Student Assistance has been a priority for Masonic Charities of Maryland (MCM) since 1987. Prince George's County is the sixth Maryland jurisdiction to be trained since the revised MMSAP training went into effect in 2010.





MSAPPA Conference

Tn its continuing support for the Maryland Student Assistance ♣ Program, MCM funded the 2013 Maryland Student Assistance Program Professionals Association (MSAPPA) Conference at the Grand Lodge on Thursday, February 28. More than 250 educators, treatment and health care professionals, social workers, and other community youth-oriented professionals traveled from across Maryland to spend this day in workshops designed to enhance their knowledge and refine strategies to help our at-risk youth. The keynote speaker, Dr. Katherine S. Newman, Professor of Sociology at Johns Hopkins University, addressed the causation, incidents, and shooter profiles of youth involved in school shootings across the country. Using research

data, Dr. Newman mesmerized the audience with facts and protective strategies helpful to prevent such occurrences.

Following this address, the attendees divided into smaller groups to hear other presenters on topics such as Female Aggression, Street Drug Updates, School Dropouts, Gang Culture, and Generational Differences.

Deputy Grand Master Ken Wyvill made brief remarks, citing the correlation of Masonry to American education and mentioned several key Masons in Maryland history. He recognized the directors of MCM who attended to show their support for the Conference and for the work that these dedicated professionals perform every day with our youth.


