We must make sure we use those additional funds correctly and remove any possible reason for the membership to regret their vote. I make this promise to the membership. We will protect your investment in this Grand Lodge. I have stated, in the past, my family history during the Great Depression and I truly understand the need to live within our established budget. The Deputy Grand Master, your Board of Managers and this office have collectively worked together toward management of that goal. For the confidence expressed by your vote, I extend my sincere Thanks.

George Washingtion Masonic National Memorial

Have you ever driven around the inner loop of the Beltway of Washington, D.C., crossed over the Woodrow Wilson Bridge and seen a telescoping building off to your right reaching skyward? Have ever driven the outer loop heading toward the bridge, and noticed this same building off to your left? Do you know what it is? Have you ever thought of stopping, and trying to find it? It is an impressive structure, which you as a Maryland Mason are a part owner.

This building is the George Washington Masonic National Memorial, and is dedicated to our first President of the United States, Brother George Washington. We are in this project for the future of Grand Lodge and we will do whatever is necessary to see it through to completion. I have stated in the past, this is your Grand Lodge and you frequently will receive updated information of our progress, in the Free State Freemason and elsewhere as the need occurs. I have every confidence I can share our knowledge with you and then be prepared to respond to your guidance. We can accomplish great deeds when we all pitch in, work toward a common goal, and do it together.

letter permitting Worshipful Masters of our subordinate Lodges the freedom to make those decisions necessary to lead their Lodges without asking for Grand Master's dispensation for every item in the letter, has been received favorably by the Craft. The letter was, in my humble opinion, just another step to allow Worshipful Masters to hone their leadership skills. With the advent of many new Lodge Secretaries. who also work for a living, it became necessary we allow some latitude in the day-to-day operation of Blue Lodge business. I am pleased with the many responses

received and hope those successors in this office will continue to share the responsibility for management of Lodge business with the Worshipful Master. This small procedural change has reduced the flow of paper across my desk and I am sure all Secretaries welcome the relief from the requirements. We need to address this subject on an on-going basis and then update it as future Grand Masters deem necessary.

Grand Lodge Summer Schools will begin in July. Our ritual is what separates us from those other community-based groups and we must always protect and assure its validity. Elsewhere in this issue is a schedule of the Summer School dates and Lodge locations. It is extremely important Subordinate Lodge officers attend and actively participate in the Schools. This Grand Master would be most pleased to meet and greet you as we travel throughout the State. My ears are ever open for comments, suggestions, and ves even criticism. My only request is please remember we are all Masons.

A final note about the three amendments to the Constitution which were voted upon at the May 17, 2004 Semi-Annual Communication. Two of the amendments were passed and a third failed to receive the required 2/3 vote. The two amendments that passed were as follows with new language underlined and [old language in brackets:

Article VII, Section 3 This amendment provides that the nominating committees, for the three Boards, must nominate all qualified applicants for the vacancies on each Board. Presently, the nominating committees nominate [one] most qualified applicant for each vacancy on the Boards. This amendment passed. It will become effective at the Annual Communication in November and change the procedure for nominations to fill the vacancies on each of the three Boards. This amendment will nullify any nominations from the floor of Grand Lodge as the nomination committees will not be able to verify qualifications.

Article X, Section 1. D.1. Revenue The revenue of Grand Lodge shall be derived as follows:

For dues and assessments, which each Lodge shall pay in the following amounts, when making its return to the Grand Secretary, as provided in Article XVI, Section 11:

1. For each member, effective January 1, 2005, semi-annual dues, Nine Dollars (\$9.00) [Six Dollars] (\$6.00) except that no Lodge shall be charged for the following members:

Clergymen who are exempt from payment of dues by virtue of the Lodge By-Laws.

Members who are determined legally to be mentally incompetent.

The amendment that failed to receive the 2/3 vote of Grand Lodge pertained to increasing the fees that are presently charged for Petitions (Continued on page 4)



(Continued from page 3) for Initiation and Affiliation.

Article X, Section 1. Revenue The revenue of Grand Lodge shall be derived as follows:

D.3. For each Mason initiated or affiliated (if a Mason of another Grand Jurisdiction, during the period reported, One Hundred Dollars (\$100.00) [Fifty Dollars] (\$50.00):

Article XVI Subordinate Lodges Sec. 5. Petitions for Initiation, Affiliation and Reinstatement

- D. Fees and assessments for Initiation and Affiliation
- 1. Initiation- No Lodge shall confer the three degrees of Masonry for a sum less then \$200.00 [\$100.00]
- 2. Affiliation- No lodge may grant affiliation to Masons from another jurisdiction for a fee less then \$100.00 [\$50.00].

This amendment failed for lack of a 2/3 favorable vote.

Bro. Leonard E. Cohen, No.25, Chairman of the Committee on Masonic Jurisprudence, advised the Grand Lodge we will have a total of 9 amendments to be voted on at the Annual Communication in November. It certainly appears our Brethren have been reading the Constitution of the Grand Lodge and are prepared to make those changes they deem necessary. While 9 amendments are a handful. I am sure we need to do whatever is necessary to make positive changes to the operation of Grand Lodge.

My Brethren, enjoy your summer break with your families and come back in the fall refreshed. ready to work for your Lodge and Grand Lodge. Hopefully I will see you at the Grand Master's Ball on July 17th, tickets are available, or at summer school (see the schedule), Harvest Home Day on September 18th, or on our travels throughout the state. My Brethren please approach me and express your thoughts; all are welcome.


