# A MESSAGE TO EACH MARYLAND MASTER MASON



Dear Brother Mason:

If you were to ask me where you could be of greatest service to the Fraternity today, I would have to point toward Cockeysville where "Bonnie Blink" - our Masonic Homes - is located.

There the older buildings stand together with the almost completed new Health Care Facility as the near fulfillment of a dream begun in 1842, some 140 years ago.

Actually, it wasn't until 1922

that Grand Master Warren S. Seipp resolved to do something about making the Homes a reality. Overshadowing the countless details involved in this monumental task was the raising of sufficient funds to purchase, operate and maintain the Homes. But the job was done under the leadership of Grand Masters Seipp, Gorsuch, Livingston, their successors and, more particularly, the individual Masons, friends, associates, Lodges and the collateral bodies whose contributions and efforts nurtured the dream into fruition.

Today we are faced with similar challenges, particularly in the furnishing and decorating of the bedrooms of the new Health Care Facility and broadening the base of our Endowment Fund which provides the principal source of income for operating the Homes.

We believe that practicing Masons are no different now than they were then. They still share a common resolve and

obligation to take care of their own.

When you attend the forthcoming Harvest Home Day at Bonnie Blink, our 55th, on October 16, or during your next visit to the Homes, take time to look at what we've wrought over the years. Look carefully at the beautiful new Health Care Facility now under roof. It would be a rare person indeed who would not be moved to make a personal contribution - who would not want to stand up and be counted - who would not want to be recognized as a practicing Mason.

Remember your contribution:

• Confirms your beliefs, convictions and your commitment to our Masonic obligations.

• Preserves our pride and independence. We have never asked nor received funds from any government agency. We are proud to be free of interference and politics.

• Remembering our Masonic Homes in your will provides a perpetual remembrance of your generosity.

# THE MARYLAND MASONIC HOMES A PROFILE

**History** 

**1842** - Future objective established for a Masonic Widows' and Orphans' Asylum.

1923 - Masonic Home Fund established. Board of Trustees of the Masonic Home Fund elected.

**1927-1930 -** Property acquired; 338.78 acres for \$87,049.53.

1928 - First Corn Husking Party - 1,250 men working three hours husked 600 barrels of corn. Souvenir penny furnished by Bro. Jacob F. Obrecht, Oriental Lodge No. 158.

1931 - Cornerstone laid of new Masonic Home - witnessed by 5,000 people.

by 5,000 people.

1932 - Dedication of new Masonic Home - witnessed by 10,000. Lodges, other Masonic bodies and individuals invited to furnish rooms - estimated cost of bedroom \$150.

1938 - Chapel constructed.

1951 - Infirmiry added.

#### **Our Current Situation**

The Problem: In 1979, health authorities gave us five years to comply with Federal, State and County regulations on physical features of the Homes or shut down operations. The Immediate Solution: In 1979-80, in order to raise funds, Grand Lodge approved sale of 140 acres with use of a portion of the proceeds to erect a new Health Care Facility. In 1981, the cornerstone was laid for the new facility.

The Continuing Problem: Funds required to furnish the new health care facility, to operate and maintain homes,

and for future development and improvement.

Cost of operating homes rising rapidly due to inflation:
 1959 \$ 370,032
 1969 603,902
 1979 1,666,677
 1982 1,990,252

 We are now breaking even through income from investments of Endowment Fund, our principal source of funds.

 Each Maryland Mason currently assessed only \$4 a year - constitutes but 8% of operating budget.

## The Future

Blessed with the leaders and men of vision who have guided us to our present circumstances, we can rest assured that future developments at Bonnie Blink will be a source of pleasure and pride to Maryland Masons.

Even now, the Long Range Planning Committee of our Board of Trustees is researching various utilization alternatives (such as apartment condominiums) and considering the experiences of others to determine and recommend the best direction for meeting our future needs.

However, our future is dependent upon what you contribute to make it happen.

# **QUESTIONS USUALLY ASKED ABOUT** OUR MARYLAND MASONIC HOMES

Most of this information are highlights drawn from pages 57 and 58 of the Grand Lodge Constitution which has been furnished to your Worshipful Master, Wardens and Secretary and is available for your information.

Who is eligible for admission?

Ans. At the discretion of the Board of Trustees, the following persons may be admitted:

 A Master Mason who has been in good standing for ten years continuously and who for at least five years continuously, preceding the date of application, has been a member in good standing of a Maryland Lodge.

The wife of such a Master Mason.

The mother, widow, or unmarried daughter of a deceased Master Mason who was, at the time of his death, a member in good standing of a Maryland Lodge.

Is age a determining factor for admission?

Ans. An applicant must be not less than sixty years of age at the time his or her application is received by the Board

May husband and wife be admitted separately?

Ans. It is the policy of the Board of Trustees that husbands and wives be admitted together at the same time.

Do physical infirmities prevent an applicant from admission? Ans. In most instances, applicants must be capable both mentally and physically, of caring for their own needs, such as dressing, eating, walking, bathing, etc.

How is application made?

Ans. An application for admission can be made only through the Subordinate Lodge of which the applicant (if a Master Mason, or the applicant's husband if the applicant is the wife of a Master Mason) is now a member in good standing, or (if a widow or dependent) whose husband, father, or son was a member in good standing of such Lodge at the time of his death.

What becomes of whatever assets I have should I become a resident of the Homes?

Ans. Upon becoming a resident of the Homes an applicant must deed, assign or transfer to the Grand Lodge of Maryland all real and personal property of which he or she may be possessed and all income from any source. Disposal of assets within two years prior to anticipation of

admission may be cause for rejection. What are some of the services and events provided at the

Ans. Religious, medical and personal services, such as laundry, dry-cleaning, hair care, etc., are provided. Facilities are available for pursuing hobbies such as sewing, arts and crafts, flower gardening and others. Bus transportation is provided for occasional shopping trips. Movies are shown and entertainment is provided by many youth, religious

and Masonic organizations. May guests leave the Homes for overnight or for a more

extended period of time? Ans. Guests may leave the Homes for the day, stay away overnight and may spend up to 30 nights away from the Homes over a period of 12 months.


