

#### BALLOTING

Balloting in a Masonic Lodge is a sacred obligation and responsibility. The use of the Ballot constitutes the very strength and foundation of Masonry.

A committee does not grant membership to a petitioner, nor does it deny membership. It is the individual Mason who has that privilege and that responsibility. After the ballot has been declared in the legal manner, the matter is closed. A Mason who tells how he intends to vote, how he voted, or speculates on how another voted, is subject to charges.

The Blackball is for the protection of the Institution. It is not a weapon of revenge. What conscience dictates that we should do. We should never cast a negative ballot to even a personal score or to satisfy an old prejudice.

There are private and public matters in which we find ourselves in disagreement with others. We should consider carefully that such differences in thought do not necessarily place us on the side of Morality and the other fellow on the side of Immorality.

There are honest differences, and it is a primary principle of Masonry to grant to another, what we take for ourselves, the right to think and to express our own thoughts. The Blackball is to prevent those from coming into Masonry who are not proper Masonic material. The question should always be: "Is the petitioner proper Masonic material?"

Let us weigh carefully. The qualifications necessary to become a Mason are known to every Mason. Let us brush aside all else and cast our ballot by the standards of Masonry.

#### **REGIONAL MEETINGS — 1983**

"Visit Your Blue Lodge" was the theme at the six 1983 regional meetings attended by Worshipful Masters, Senior Wardens, Secretaries, Grand Inspectors and Deputy Grand Lecturers.

Briefers and discussion leaders included: MWGM Harvey T. Hopkins, RWDGM C. David Haacke, PGMs Wm. M. Koenig and Bernard E. Rothman, RWSGW Wm. M. Clark, Jr., RWGS Jack R. Frazier, Bro. Joseph C. Bryan, III, Interlocutor, and Bro. Jerome Fields, Pres., Board of Grand Inspectors (Baltimore City and County).

Highlights included remarks by GM Hopkins expanding on the theme of the meeting that an increase in Blue Lodge attendance is contingent upon the imagination and efforts of Blue Lodge leaders who must develop interesting and informative programs; improvement of the quality of instruction and ritual work; getting members and newly-raised brothers involved in Lodge projects and tasks; and promoting pride and publicity on the aims and accomplishments of Masonry. He reminded all that the Blue Lodge is the foundation of all Masonry; and that Freemasonry is as Freemasons are.

PGMs Koenig and Rothman reported favorably on the status of construction and finances at Bonnie Blink. That of the 100 bedrooms in the new Health Care Facility, 55 have been paid for (\$2,500 donation for each bedroom), 30 are partially paid for, and 15 are available for pledges.

Worshipful Masters will be informing their Lodges of what they learned in the presentations and work sessions; and taking action to implement guidance received.
