

This, my Brethren, is an example of apathy raising its ugly head. We must not allow it to take over our Grand Lodge!

While the visitation schedule for January is lengthy and ambitious, rest assured your Grand Lodge Team is busily preparing for the Regional Meetings beginning February 4, 2006. The first of those meetings will be

here in Cockeysville and there is much to be communicated and discussed. I will be meeting with Grand Lodge Council and have a better idea of how to best write this amendment which will be presented in May to be voted on in November. I need your input and consideration on this topic but, I feel we should as a Grand Lodge consider this path as trials are difficult and divisive causing great strain on our individual members and our Lodges. Please give this concept some thought and come prepared with your ideas. Our Deputy Grand Master will also be sharing his ideas for his term during this year's regional meetings and I'm sure it will be of interest to all. These are but two of the topics that will be presented at regional meetings this year and I trust you will come out and share in the experience.

I am pleased to report that the Masonic watch program that was initiated this fall has netted better than \$20,000 for the John Coat's Memorial Fund. I can only express my profound thanks and appreciation to the Craft for their support of this Grand Lodge fund raiser. The initial estimate stated we would net around seven to ten thousand dollars on the project. Once again Maryland Masonry has stepped up and exceeded all expectations. Thank you!

Masonic Charities of Maryland is initiating another raffle and yes, we have heard the message of the Craft. We're back to offering a Harley Davidson motorcycle. While the boat met with limited success the Craft has spoken and we have reacted accordingly, so all you bike riders out there get ready. ALL FUNDS must be raised! There will be no Grand Lodge or Maryland Masonic Homes contribution.





From the Deputy

Greetings Brethren; my best



wishes to you and your family as we begin a new year in our fraternity and our lives.

This should be an exciting

time for our Lodges. We are in the process of installing officers who will guide their Lodge for 2006. The Grand Master and his Grand Line have already attended installations in several Lodges, and I have yet to see one that didn't have to put out extra chairs to accommodate the crowd. That is truly a pleasure to see.

Our Grand Master speaks regularly about the success of Lodges that are active in their community, and that is but one of the things we should pursue vigorously in some manner if we truly want to sustain our wonderful fraternity. Any Lodge that is not connected with its community needs to consider becoming involved for the following reasons:

Future members are in the community and when the Lodge is involved, they will discover what Masonry is all about. Future members demand that any organization they join be active in community projects. The community is the responsibility of everyone - including Masons. The Lodge is a perfect community-service organization. Masons will be proud of their role in the community. Any organi-

zation, to grow, needs to be able to involve all its members in some way. Community involvement is one way to do this. The best way to get members involved is to respond to a need in the community. Here are some ideas:

Members can man a booth at local events, distribute information and answer questions regarding Masonry. Give a Scholarship. Sponsor a Scout Troop. Host four events during the year on weekends for members and guests. Members can prepare food, run games and hold a collectibles auction. Meals on Wheels route - the lodge can adopt a route that would serve two meals a day for eight families for a year. Roadway beautification - Masons can join with vouth groups (DeMolay, Jobies, Rainbow, etc.) to maintain a section of the roadway in town. Improve a playground. The lodge could take on the fix-up, paint-up, clean-up of a local playground.

We are not trying to turn Freemasonry into a service club. The real importance is not to change what the Lodge is doing, but to increase member interest, participation, awareness and pride through family and community involvement. Local government is trying to establish partnerships with organizations in the community that can solve community-related problems without a lot of fuss. Individuals in the community tend to evaluate the relevance of organizations by the degree of their involvement.

Some things that even a small

lodge with less than 100 men can accomplish are:

Sponsor a 4th of July celebration and picnic every year. Sponsor a grade school basketball tournament. Provide medical supplies for a local EMS unit. Provide funds and labor to renovate a local ball field. Sponsor a local youth to a Shrine Bowl Band Camp. Raise funds to assist a public library. Adopt a needy family at special holidays such as Thanksgiving and Christmas.

The list can go on and on and is only limited by the imagination of you and your members. Get involved!

We are all "Seeking a Future" for our organizations and each presented a short discussion on their group and the charitable contributions of the collateral bodies. It is estimated that daily the Masonic bodies throughout the nation contribute \$2 million. A decision was made to continue doing other joint efforts and plans are now underway. The evening was a success and filled with fun, food and fellowship.



Who Are These Men Called Masons?

Masonry (or Freemasonry) is the oldest and largest fraternity in the world. No one knows just how old it is because the actual origins are disputable even among historians of Freemasonry. It is generally assumed that Masonry arose from the guilds of stonemasons who built castles and cathedrals in the Middle Ages. Perhaps it was influenced by the Knights Templar, a Christian military group formed to protect the pilgrims on their way to the Holy Land. To become a Master Mason in the guilds of stonemasons, it was necessary to spend several years of training in the art of masonry, where lessons were taught by means of allegories. Freemasonry uses the same methods. Originally, only the practitioners of the mason trade could become members of the guilds of Master Masons. Sometime later, men of good character, and not stonemasons, were admitted to these guilds, or lodges. Today, there are over 13,000 lodges in the United States alone, with a membership of nearly 2.5 million. There are nearly 6 million Masons throughout the world.

Some believe that Masonry is a secret society. Quite to the contrary or this article would not be written. Masons would not wear pins and rings proclaiming their membership, the lodges would not bear signs identifying them, etc. Masonry does have secrets, as do most fraternities. Masons have secret grips

and passwords. This comes from the stonemasons who needed such a means of positive identification as they traveled from site to site for employment.

What is our purpose? To make good men better. Freemasonry respects the religious beliefs of all its members. Freemasonry has no theology and does not teach any method of salvation. Freemasonry does not discriminate on the basis of race, religion, or social class. In a lodge, all men are equal. The solemn promises taken Freemasonry are no different than the oaths taken in court or on entering the armed services. The muchdiscussed "penalties," judicial remnants from an earlier age, are symbolic, not literal. They refer only to the pain any honest man should feel at the thought of violating his word.

What do we do? Most everyone is familiar with the Shriner's Hospital for Crippled Children and Shriner's Burn Institutes, but are not aware that every Shriner is a Mason! They are also not cognizant of the philanthropic work of the Royal Arch Research Assistance program which funds research in Central Auditory Processing Disorders, the Cryptic Masons Medical Research Foundation funding Vascular Biology Research in Arteriosclerosis (heart disease), the Knights Templar Eye Foundation, providing research, surgical assistance, and hospitalization (annual grants of \$10,000 - \$30,000 to the Wilmer Eye Institute at Johns Hopkins Hospital), the Tall Cedars

of Lebanon supporting Muscular Dystrophy. the Scottish Rite Institute for Childhood Aphasia, Dyslexia, Dyspraxia (the Speech and Language Center at the Scottish Rite Temple in Baltimore). The benefits of many of these programs are available, at little or no cost on an individual basis regardless of race, creed, or color. And let's not forget the Masonic Ladies, for they contribute to mankind in the following ways: the Social Order of the Beauceant support of the Knights Templar Eye Foundation, Amaranth Diabetes Foundation, the Eastern Star Cancer Research Project plus their Eastern Star Training Awards for Religious Leadership, the White Shrine of Jerusalem "Rehabilitation" project, and the International Order of Job's Daughters (a Masonic order for young girls) Hearing Impaired Kid's Endowment Fund, to name just a few. Freemasonry in the United States contributes in excess of \$1.5 Million daily to philanthropic causes.

Who are some of these men who are, or were, Freemasons? To name a few: Edwin E. "Buzz" Aldrin, Roy Acuff, Irving Berlin, Ernest Borgnine, Ty Cobb, Arthur Conan Doyle, "Duke" Ellington, Gerald Ford, Benjamin Franklin, Clark Gable, Rudyard Kipling, Wolfgang Mozart, Roy Rogers, "Red" Skelton, and John Wayne.

Finally, a quote from Dr. Norman Vincent Peale, noted pastor: "To me, Freemasonry is one form of dedication to God and service to humanity."

In 1985, the Masonic Charities of Maryland asked Sharon Lodge No. 182 to present a scholarship to a graduating senior of Owings Mills High School. Masonic Charities of Maryland said that they would reimburse Sharon Lodge for half the scholarship up to \$250.00. We continued to give two \$500.00 scholarships even after Masonic Charities of Maryland stopped the program.

For a few years we continued to present these two scholarships, then recently we increased these scholarships to two scholarships at \$1000.00. In 2004, we added two more scholarships of \$1000.00 to Sollers Point Technical High School in Dundalk Maryland. These recipients will go on to careers in health, such as nursing, physical therapy, radiology technicians, or possible physicians. In all we award \$4000.00 in scholarships. A Fraternity within a Fraternity

Philanthropic No. 168 New Market, Maryland is growing. While we may not be the largest, newest or fastest growing Lodge in the State, we have been growing at an impressive rate.
