

A MESSAGE TO EACH MEMBER OF THE MARYLAND MASONIC FAMILY



The sands of the hourglass of this Grand Master's term are running out all too rapidly.

There is yet much to be done however, to assure that the sands of Masonry in Maryland will never run out.

My objectives and programs over the past two years have primarily dealt with instituting actions to safeguard our future.

- One of them was to unify, synchronize and mutually support the efforts of the Masonic Family in our future endeavors.
 - · Another was to rally and rein-

force our Youth - the future of our Fraternity and our Country. Not only was this effort directed to the Jobies, Rainbows and DeMolays but also to our support of a National Foundation for the Prevention of Drug and Alcohol Abuse among children.

- A third was to reverse the decline of membership through our Solomon II Program by publicizing the purposes and accomplishments of Masonry and attract men of high moral character.
- Then there was one where we marshalled our strength behind Bro. George Della and successfully fought proposed legislation which would have done away with the exemption of property taxes we now enjoy and threatened many of our Lodges with financial disaster. Brethren, we are not out of the woods yet. Let us ever be on the alert for political opportunists and proposed booby-trapped legislation.
- With the establishment of the Masonic Charities of Maryland, Inc., we have created a mechanism where contributions to Grand Lodge for educational and charitable purposes are made tax deductible for donors.
- Of paramount importance is our future financial security which underlies and energizes our institution. One measure taken was the establishment of the Dr. John Coats Memorial Lodge No. 1787 where proceeds from memberships are placed in a fund from which the income is applied to worthy projects we could not otherwise maintain from our limited resources.
- Another and more crucial step towards future financial security is a series of amendments to the Grand Lodge Constitution to be voted on at the November Grand Lodge Annual Communication. In essence, an increase only in initiation and affiliation fees will enable us to fund substantial operating deficits which have occurred in recent years; the alternative being to raise per capita assessments. I urge you, my brothers, to do some soul-searching in your Lodges and be sure that your Lodge is represented to vote on these amendments in November. Each Lodge is entitled to two votes which may be cast by proxies if Lodge members are not available to attend Grand Lodge.

Although we are irresistibly drawn into a future which appears foreboding and veiled in darkness, I am convinced that we can survive by continuing to trustingly follow the paths mentioned above.

Congratulations to each of you, your family and friends! You have performed a most excellent job rekindling interest in and programs of Masonry. Your response to the recognition of The Masonic Family, the Solomon II Program and the Dr. John Coats Memorial Lodge #1787 has been overwhelming. It is to you that Maryland Masonry owes a big "Thank You"!

My best wishes to you and yours for a future of fulfillment and health. And, again, congratulations!

GRAND LODGE COMMUNICATION NOVEMBER, 1986

In addition to the regular order of business, including election and appointment of Grand Line officers, several amendments to the Grand Lodge Constitution will be considered. The purpose of these amendments is substantially as follows:

- To increase initiation and affiliation fees. (This is applicable only to new members; it does not affect existing members of Lodges).
 Clergymen are exempt from fees if the Lodge By-Laws so provide.
- To require along with the petition for initiation or affiliation an additional \$5.00 assessment for the George Washington Masonic National Memorial Association. This amendment is not applicable to existing members of Lodges.
- To adjust allocations of that portion of initiation/affiliation fees transmitted to the Grand Lodge between the Grand Lodge Operating Fund Account and the Dr. John Coats Memorial Fund which is an endowment fund.
 - · To provide a framework for merger of Lodges.

STILL GOING STRONG

The oldest Masonic Lodge in continuous operation in the United States is Solomon's Lodge No. 1, F. & A.M. which was organized by General Oglethorpe in 1734. It is now located in the Cotton and Naval Stores Exchange at 100 Bay St., Savannah, Georgia. The exchange was the center of commerce when Savannah was the world's foremost cotton port. The building shown below is the first to straddle a public street according to the legal principle of "air rights."



By the way, the oldest Masonic Lodge in Maryland is Washington #3 which was instituted in 1770. At least, that's what it says on a commemorate plate owned by Bro. Tom Harvey of Temple Lodge #11, Wilmington, Delaware. The plate was issued on the occasion of the 200th anniversary of the birth of Bro. George Washington.

He lost them in 1965 at age 6, when he was run over by a train in East Baltimore. His case came to the attention of Bro. Lloyd E. Phillips who arranged to have him admitted to the Philadelphia Shriners' Hospital for crippled children. He was treated, fitted with artificial limbs and returned home.

Some time later, after numerous hospitalizations, Jim started playing sandlot softball without artificial limbs, managing to get around the bases as fast as his peers. He became extraordinarily capable as a softball umpire working for the Baltimore Department of Recreation. Jim also held the national title as Singles Racquetball Champion of the Handicapped for four years in a row.

Jim was selected to the U.S. All-Star Basketball Team which participated in the international wheelchair tournament this Summer in Madrid, taking first place; and London, where they won a bronze medal.

He is employed at the Social Security Administration and was married this past June to Miss Nancy Thompson.

As pointed out by John Steadman, sports Editor for the News American, in numerous articles, "Jim Leatherman is a remarkable example of what the human spirit can accomplish if given a chance to assert itself;" also, "that determination can carry a man to the heights of his potential whether he's three feet tall, without legs, or the size of a towering oak, if he will only give himself a chance."


