







FREEMASONRY is the oldest fraternal organization in the world. It is dedicated to promoting improvement in the character of its members. A Mason is taught to be a good citizen, to be of good character, to care for those less fortunate, and to give back to his community.

THE MASONIC FRATERNITY contributes over \$1 Billion each year to its philanthropic pursuits. Over \$750 Million of that in the United States alone. The Crippled Children's and Burns Hospitals sponsored by Shrine Masons are world famous for thetir ability to help those most in need.

FREEMASONRY traces its roots to the Middle Ages. It is from associations of stone masons, who built the magnificent cathedrals, castles, and monasteries of Europe that the fraternity started. Eventually, these groups began to accept members who were not actual working masons. At that time they adopted the term "accepted" Masons, and Freemasonry was born.



#### THE OPEN HOUSE

My brothers, this issue is brought to you at a time when throughout the jurisdiction we have completed our first statewide open house. The event was the culmination of ninety days of a media or public awareness campaign that told the men of Maryland that to be a member of our fraternity you need to "ask a Freemason". Indeed, many good men did ask, and are continuing to do so. Our Lodges needed to be ready for this increased interest generated, not by others such as Dan Brown, etc., but by our own efforts. A renewed sense of pride in being a Freemason was created by these labors. Lodges cleaned, painted and renovated their buildings. In a sense, the buildings were made "company ready" for the big day. Turnout for the Open House was tremendous. It provided a tremendous opportunity for Maryland Freemasons to tell the Masonic story.

These past ninety days have seen brothers who had been suspended for non-payment of dues request a return to active status. Our amnesty program, which sees about 20 requests a year for return to active status, now has twenty per month wanting to once more become active. Without question, this interest in the amnesty program was influenced by the prevalence of our media campaign.

#### AMNESTY PROGRAM

Initiated by PGM Bélanger, this amnesty program permits a Worshipful Master to request that the MWGM allow a brother, who has been suspended for non-payment of dues, to return to active status by paying one year's dues and earn reinstatement.

# GRAND MASTER'S MESSAGE

The individual brother does not request amnesty to the MWGM, it is the Worshipful Master, who at the behest of his Lodge, requests the dispensation from the MWGM in the name of the suspended brother.

#### THE FREE STATE FREEMASON

You will of course notice that this publication has taken on a new appearance. We trust you will like this new format, but more importantly, see the *Free State Freemason* as more readable due to this format and more interesting to read because of its contents.

#### **GRAND MASTER'S CONFERENCE**

Finally, as this column is being composed, the Maryland delegation is returning from the annual Conference of Grand Masters of North America held in Denver, Colorado. We return with new ideas, affirmation that we are on the right track, and new friendships. It was my honor to serve as chair of the 2011 Planning Committee of the Conference of Grand Masters of North America. To my surprise, I was elected General Chairman for the 2012 Conference to be held in Atlanta, Georgia. In recent years, Maryland has been quite active in this organization. In 2011 our current MWGM served as Planning Committee Chair, and in 2012 our MWGM will serve as Conference Chair. Thus in 2014 when the Conference of Grand Masters of North America is held in Baltimore for the first time, we should be experienced in the requirements to host a successful conference. Our then MWGM will serve as host Grand Master.

As winter has ended and spring begun, may all of you and your families find time for renewal and rejuvenation. Thank you to all who helped make our *Open House* on April 2<sup>nd</sup>, 2011 such a wonderful day. All the hard work and dedication made this an event one of which we all, all of us, can be proud.

# A Note from The Stephen J. Ponzillo, Jr. Memorial Library & Museum THE MERCER BOWL

Many may wonder what the purpose of a museum is and why items are placed in its care. Museums exist in order to tell the story of various artifacts though their preservation. Often, exhibiting the items fulfills this goal. Among the many items in the museum's collection is a punch bowl decorated with several American patriotic symbols which has a remarkable history of ownership, or provenance, prior to being given to the museum.

Unlike what many of us are familiar with today, punch was initially a highly intoxicating beverage made from a simple mixture of five canonical ingredients: lemon or lime juice, sugar, water, "spice" (usually nutmeg), and liquor. Gentlemen, and sometimes ladies, in London and throughout the British colonies would gather in private homes and in "punch houses" to indulge in drinking this intoxicating mixture. Often large bowls, such as the one in the museum's collection, would be place on the floor rather than on a table to prevent the bowl from being broken during these gatherings. Among the earliest records of Masons in Maryland from 1759-1764, the records of the Old Leonardtown Lodge, St. Mary's County (which meets on Sundays), are receipts for the purchase of the various liquors and other ingredients used to make punch.

Produced in England around 1795, this bowl also represents a group of objects made after the American Revolution during the Federal Period, roughly 1788-1825, when British manufacturers, anxious to retain the American market after the war, produced a variety of wares designed to appeal to the new American Republic. These items were often decorated with American patriotic symbols, which were still being developed during the period. On the outside of this bowl there is an American eagle with a shield decorated with the stars and stripes and two depictions of George Washington. Ironically, this bowl with its depictions of Washington was presented by George Washington while he was President to Brigadier General Benjamin James

Mercer, whose name appears on the outside of bowl, upon his retirement from the United States Army in 1795.

Benjamin Mercer, listed in the first Baltimore directory of 1796 as both constable and innkeeper—with his address at 34 Light Street, was Baltimore City's first policeman. He was appointed constable in 1798, a year after Baltimore was incorporated as a city, after the City Council passed an ordinance calling for the appointment of a constable "whose duty it shall be to walk through the streets, lanes and [alleys]

of the city daily with his mace in his hand, taking such rounds that within a reasonable length of time he shall visit all parts of the city." He retired from this post in 1799 when the City Council, finding that keeping law and order in Baltimore was too large of a task for one man, appointed one constable for each ward. The last record of Benjamin Mercer is in 1802, when he renewed his tavern license.

This bowl was inherited by Brig. Gen. Mercer's daughter, Mrs. Jury, who bequeathed the bowl to the Museum in the 1830s. Unfortunately, when the husband



of a cousin of Mrs. Jury, who was a Mason, went to collect the bowl to present it to the museum, his wife took a liking to it and took it home. The bowl did not resurface until after their deaths when the bowl came up for auction in 1896 as part of their estate. Hearing of this and aware of Mrs. Jury's initial wishes, Miss Connie Jury, a great niece of General Mercer, informed Bro. William H.



Nicholson, Grand Tyler at the time, of the pending sale. With approval only a few hours before the auction commenced, Nicholson was able to bid for the bowl on behalf of Arcana Lodge No. 110. The Lodge presented the bowl

to the Museum on October 13, 1896, thereby getting it to its intended destination.

The history of this bowl represents the best and worst of people and touches an aspect of American history which could otherwise have been easily forgotten. In keeping with the new museum displays, a new label, giving a synopsis of the bowl's history, has recently

been placed with the bowl. Many of the items in our collection are being more fully labeled to give visitors a better understanding of the items and the reason for their display.

# SPRUCED UP FOR THE OPEN HOUSE


