

GRAND MASTER'S **MESSAGE**

Brethren,

The have just finished the last of our Regional **V** V Meetings for 2024. Thank you to those who were able to attend, the speakers who presented many interesting topics, to the several Lodges and Temple Holding Corporations for the use of their buildings and providing lunch.

Many of our Lodges are busy with the business of Freemasonry. As of this writing in our jurisdiction we have 63 men awaiting to receive the Entered Apprentice Degree, 186 in the Fellowcraft and 94 in the Master Mason Degree. These degrees are not concentrated in one area of the state but are spread evenly throughout Maryland and Lodges are doing the de-

gree work, in their Lodges with their officers; sometimes with the assistance of officers from neighboring Lodges. This, my brethren, is how I believe it should be and the degree work I have seen, for the most part, has been quite good.

Please remember Worshipful Masters, if you need any assistance with degrees do not hesitate to communicate with your Deputy Grand Lecturer or the Grand Secretary. There are also several Third Degree Teams across the state who would come to your Lodge and confer the Master Mason Degree-

if you want to give you officers a break, as our constitution reads:

Many of our Lodges are busy with the business of Freemasonry. As of this writing in our jurisdiction we have

186 in the Fellowcraft and

94 in the Master Mason Degree.

• Permission is granted for any Grand Lodge authorized Degree Team such as the Tall Cedars Degree Team, Boumi Shrine Knights of Mecca Degree Team or the Maryland Shield and Square Club Degree Team, to confer the Master Mason Degree.

On the current Grand Line, we have four "Master Ritualist" Medal holders, RWDGM Randall L. Watson, RWJGW Barry S. Bosley, RWGS Bro. Kenneth R. Taylor and our Grand Lecturer W. Bro. William G. Richards, III: these Brothers have all offered up their services to any Lodge short an officer or two to assist in conferring the degrees. All these brothers are busy, so please give them as much lead time as possible if you have a need.

Compass Points - This is available to Lodges and collateral bodies to "Get the Word Out" about events you are holding. If your Lodge is conferring degree work, please post the information in Compass Points. This will give the Lodges of the state an opportunity to attend your EA, FC, or MM degree; nothing is better than a full room for a conferral-as the RWDGM stated at the Regionals-both he and I are out most evenings visiting Lodges and if you are conferring

> work and we know about it, we will make the effort to attend.

SEMI-ANNUAL

The Grand Lodge Semi-Annual is Saturday, May 18th, 2023, coffee, and donuts at 8AM with Grand Lodge Opening at 10AM. There will be Constitutional Amendment to be voted on and elections for Grand Lodge Officers for next year-the resumes of those standing for election are in this issue.

As Grand Master, I will not be starting any new programs (we currently have 26 and I feel that is enough), awards, etc. but concen-

trating on continually improving the degree work in our constituent Lodges (for the benefit of all) and

several small corrections/improvements in those programs already in place. The Maryland Masonic Academy has been charged with editing their "modules" and source documents (Portals, etc.) to bring the information presented in line with our jurisdiction. Thank you to MMA President Benjamin A. Zamostny for spearheading this endeavor. One other item is the Worshipful Master's Certification Formfor several decades the Grand Lodge has talked about changing the Form so a Past Master (who is once again taking the East) does not have to hunt down his DGL to confirm he has certified in the three degrees or the Chairman of his area Law School or the Secretary of the area PM Association to sign his form. Well, we are finally going to move forward, starting with the 2025 Installations a Past Master ascending to the east will only have to fill out that he, the SW and JW together with the Grand Inspector will read article XVI and the Secretary will certify all the officers have been installed. This new form will be explained and displayed at the Semi-Annual in May.

For 2025 the Grand Lodge added a line item in the budget for Social Media Advertising (\$10,000) and for our first month we have received 60 inquiries which have been passed on to constituent Lodges. These inquiries are from all areas of the state and not just concentrated in the I-95 corridor as in our past efforts.

The Deputy Grand Master and I continue to work together to assure there will be continuity over the next few years and in all questions look to the Constitution of the Grand Lodge to assure any decisions made are in compliance with this governing docu-

I look forward to seeing you in May and maybe even sooner, in your Lodge.

DEPUTY GRAND MASTER'S MESSAGE

Brethren:

As I write this, we have just completed the Regional Meetings for 2024. It's good to be able to see so many interested Masons around the state gathered together to share information and fellowship on the several Saturday mornings. I appreciate all the comments and questions during the presentations, and especially the discussions before and after the formal sessions.

The Grand Master and I both share the belief that a primary aspect of the leadership positions in the Grand Lodge is the support of our local Lodges; and that this is best served by first-hand observation, participation, assistance, and discussion. To that end, we are both out just about every evening and most weekends. Unless there's a particular reason that we should both be at the same Lodge event, we usually try to split up; and we coordinate our calendars to try to maximize our exposure to the Lodges across the state.

In his first year as Deputy Grand Master, C. David Haacke (PM of Chester No. 115), made it a personal goal to visit every Lodge in the state before the end of his term as Grand Master. This impressed me at the time, and I have adopted the same goal. In 1983 there were 128 Lodges; there are currently 100. In the just under a year and a half since being installed as Deputy Grand Master in November 2022, I've visited 66 of these Lodges, so 34 remain to be covered. (I've actually visited 67 different Lodges, but one of them, Waverly No. 152, has merged with Mt. Moriah No. 116, and although I visited both, I guess I should only count them as one.



In these travels, a lot of Brethren have asked about how much time and mileage is involved in the position, so I'm taking this opportunity to share some of the numbers with you all, and update those which were included in my address at the Annual Grand Communication in November. For the 66 (or 67) Lodges visited as your Deputy Grand Master, in addition to the four Grand Lodge Boards (Managers, Trustees, Masonic Charities of Md, and the SJP, Jr. Library & Museum) I've attended:

- 162 Maryland Lodge meetings and events
- Degrees for:
 - **40** Entered Apprentice Initiations
 - **20** Fellowcraft Passings
 - **59** Master Mason Raisings
- **9** Memorial Services
- **8** Past Masters' Associations
- 17 Masonic Youth Groups
- 13 Masonic out-of-state
- 17 Schools of Instruction
- 107 York Rite, Scottish Rite, Eastern Star, and other Masonic Bodies

In these visitations, I've driven over 29,000 miles: 8,368 in my personal car from November 2022 until May 2023, and 21,218 in the Grand Lodge's Ford Escape since May 2023. We got the hybrid power plant for the Escape, and it has averaged 39.8 miles per gallon. I'm a member of Sam's Club, and gasoline for the Escape has averaged \$3.13 per gallon.

In Masonry, we often refer to each other as a "Traveling Man". This is usually meant in a figurative sense, but in some cases it applies literally. Shortly after he was raised in September of 2017, Paul Cole, Senior Warden of Stephenson No. 135, made it a personal goal of his to visit every Lodge in the state. He accomplished this goal in just under 6 years. You can ask him for his vantagepoint as a relatively new Mason on how getting around and meeting Brothers throughout the state has broadened his perspective and appreciation of the Craft. We, more seasoned Masons, can also gain by such personal contact.

So, if the Grand Master or I show up unannounced at your Lodge, don't get nervous or automatically go into a panic. If we show up in a suit or jacket & tie, you can be comfortable that we're just there for a fraternal visit to share camaraderie, even if a couple of other Grand Line Officers are with us. However, it goes without saying, that if we unexpectedly show up in a group and all in Tails, there might be some cause for concern.



Rethren, this is a call for all Masons to support the Stephen J. Ponzillo Jr. Memorial Library & Museum (aka Maryland Masonic Museum)!

This is the nation's oldest Masonic Museum, and one of the largest Masonic libraries in the country. But the Board of Directors needs your help!

We have started an Endowment Fund for the perpetual benefit of the Museum and Library. The Museum/Library Endowment Fund is necessary to not only support the Museum and the Library in maintaining and preserving what they possess, but also to enable them to grow and expand their offerings and availability. Without the Fund, they are destined to deteriorate, wither and close. Remember, the Museum is your LEGACY, as well as that of Maryland Masonry!

The Endowment Fund is open to Masons and non-masons alike, with a goal of raising \$500,000. All donors will be recognized and publicly displayed. Donations for individuals start at \$100.00. Contributors of \$10,000 or more will have a permanent seat on the Advisory Board of Regents, the body that will supervise and manage the Endowment Fund investments and spending. Masonic lodges and other Masonic related bodies can start donations at \$500.00, and with a \$15,000 donation can also have a permanent seat on the Board of Regents. The individual, business, company or Masonic body with the largest contribution will have naming rights for the Fund. Recognized levels of contributions will include \$100, \$500, \$1000, \$2500, \$5000, \$7500, \$10,000 and \$15,000.

Those Masonic bodies that wish to become permanent members of the Board of Regents but can't put the \$15,000 together alone, may wish to form a group or partnership with one or more other bodies in order to collectively meet the goal, and have the seat rotate among them on an annual basis. An example could be the Frederick, MD Group, or the United Masons of Cecil County.

Remember, brethren, the MD Masonic Museum is a 501(c)3 charitable organization, so all donations to the Museum and the Library are tax-deductible.

Brethren, the goal is attainable and the purpose is gratifying! The money donated for the Endowment Fund will NEVER be spent! It will create a fund that will generate interest each year to meet the expenses and needs of the Museum and Library. The money for the Endowment Fund and the interest produced by it can ONLY be used for the benefit of the Museum and Library. This means they will be more inviting, entertaining and available.

There will be an open Endowment Fund Kick-Off event (Masonic Legacy Night) at the Grand Lodge Ballroom on Saturday, August 10, 2024. There will be food, drinks and speakers. It is hoped that every lodge will have made a donation by that time, or will have announced their intention to do so at the event. Donations from individuals, families, businesses and other Masonic bodies are also appreciated and will be announced.





PROPOSED AMENDMENT #1 TO CONSTITUTION

(New language <u>underlined in bold font</u>, deleted language struck through.)

Article XVI, Section 11, Returns to Grand Lodge

Current Language:

A. Semi-Annual and Annual Returns – As of the last day of June and December of each year, every Lodge shall make a return of its members to the Grand Secretary, stating particularly: the date of each initiation, passing and raising; the degrees of its members; admissions; deaths; rejections of candidates; suspensions, expulsions and reinstatements of members; the Lodge name and number; and the time and place of its stated meetings. The returns shall be in the form that Grand Secretary directs and shall be signed by the Worshipful Master and Wardens and attested to by the Secretary. Returns of June 30th shall include a complete list of all members. Returns of December 31st shall be an abstract of the membership. These returns shall be forwarded to the Grand Secretary on or before the 31st day of July and January of each year, together with payment in full amounts due.

Proposed Language:

A. **Semi-Annual and Annual Returns** – As of the last day of June and December of each year, every Lodge shall make a return of its members to the Grand Secretary, stating particularly: the date of each initiation, passing and raising; the degrees of its members; admissions; deaths; rejections of candidates; suspensions, expulsions and reinstatements of members; the Lodge name and number; and the time and place of its stated meetings. The returns shall be in the form that Grand Secretary directs and shall be signed by the Worshipful Master and Wardens and attested to by the Secretary. Returns of June 30th shall include a complete list of all members. Returns of December 31st shall be an abstract of the membership. These returns shall be forwarded to the Grand Secretary on or before the 31st day of July and January 30th day of September and the 31st day of March of each year, together with payment in full of amounts due.

PROPOSED AMENDMENT #2 TO CONSTITUTION

(New language underlined in bold font, deleted language struck through.)

Part 1 – Article XVI Subordinate Lodges; Section 5. Petition for Initiation, Affiliation and Reinstatement; E. Balloting

Current Language:

5. A Mason shall not be reinstated without the unanimous consent by ballot of members. This does not apply to members under definite suspension or those suspended for less than six months for non-payment of dues. No member, having been suspended for a period of three years or longer, whether it be for non-payment of dues, disciplinary suspension or otherwise, shall be reinstated without submitting to the same background check required of new petitioners. This includes those requesting dispensation for amnesty.

Proposed Language:

5. A Mason shall not be reinstated without the unanimous consent by ballot of members. This does not apply to members under definite suspension or those suspended for less than six months for non-payment of dues. No member, having been suspended for a period of three two years or longer, whether it be for non-payment of dues, disciplinary suspension or otherwise, shall be reinstated without submitting to the same background check required of new petitioners. This includes those requesting dispensation for amnesty.

Part 2 – Article XVI Subordinate Lodges; Section 7. Membership

Current Language:

B. **Plural and Dual Membership** - A member of a Maryland Lodge may affiliate with other Maryland Lodges and shall be known as a *Plural Member* if he is subsequently elected to membership in those Lodges. A member of a Lodge or Lodges in other Grand Jurisdictions, whose Laws do not forbid dual membership, may affiliate with a Maryland Lodge if he is at least eighteen years of age and meets all other requirements of affiliation and shall be known as a *Dual Member* if he is subsequently elected to membership in that Lodge. In both situations his application must be accompanied by a current certification of good standing from his home Lodge.

Proposed Language:

B. **Plural and Dual Membership** - A member of a Maryland Lodge may affiliate with other Maryland Lodges and shall be known as a *Plural Member* if he is subsequently elected to membership in those Lodges. A member of a Lodge or Lodges in other Grand Jurisdictions, whose Laws do not forbid dual membership, may affiliate with a Maryland Lodge if he is at least eighteen years of age and meets all other requirements of affiliation, **shall submit to the same background check** required of new petitioners and shall be known as a *Dual Member* if he is subsequently elected to membership in that Lodge. In both situations his application must be accompanied by a current certification of good standing from his home Lodge.

PROPOSED RESOLUTION #1

WHEREAS the Grand Lodge of Maryland approved an amendment to Article X. Section 1. D. of the Constitution at the Annual Communication in November 2012, reading in part:

5. For each member, for the use, maintenance and support of the Maryland Child Identification Program, Three Dollars (\$3.00) annually, beginning January 1, 2014 and lasting ten (10) years or until the Grand Lodge of Maryland decides to discontinue the program, whichever occurs first, except that no Lodge shall be charged any assessment for the following members:

Which section was deleted in its entirety at the Annual Communication in November 2021;

And WHEREAS the Board of Directors of Masonic Charities of Maryland, Inc. (MCM) is responsible for funding and maintaining the Maryland Masonic Child Identification Program;

And WHEREAS said Board of Directors has unanimously agreed that there are sufficient funds under the auspices of MCM to fully fund the Maryland Masonic Child Identification Program for as long as the Grand Lodge of Maryland continues said Program;

And WHEREAS the Grand Lodge of Maryland collected funds on a \$3.00 per capita basis for a period of nine years from its membership;

And WHEREAS the funds collected under this section were restricted by the Grand Lodge for the support of the Maryland Masonic Child Identification Program; therefore, be it

RESOLVED, that the remaining funds collected to fund the Maryland Masonic Child Identification Program be redistributed to all current Maryland Lodges on a per capita basis for the purpose of each lodge making a donation to the local charity of their choice as follows:

- A. Lodges will be provided a period of ninety (90) days to select a charity for said donation. As a key purpose of the Child Identification Program is community involvement, no Masonic-related charity is eligible for selection.
- B. At the conclusion of said ninety (90) days, the funds will be distributed to all lodges who have designated a charity of choice as a Masonic Charities of Maryland check. Lodges who do not designate a charity during this time period will not be included in the fund distribution. The check will be made out to the charity selected by the lodge for presentation. The fund for the Maryland Child Identification Program will then be dissolved and all future financial requirements for maintenance of the Program will be funded from the MCM General Fund.

And be it further RESOLVED that, since the restriction on the use of the collected funds to the Maryland Masonic Child Identification Program was imposed by a 2/3 majority of the Grand Lodge, that this RESOLUTION shall require a 2/3 majority for approval.
